

## WHAT TO DO IF YOU ARE IN AN ACCIDENT

---

- **STAY SAFE!** – Get out of harm's way; do not exit your vehicle if you are in traffic or otherwise not safe. Lock your doors and wait for the police to arrive.
- **CALL 911** – Always report a collision. Resist the temptation to exchange information without an officer or a witness present at the accident scene.
- **DO NOT ADMIT FAULT** – The proper investigation will determine liability for the collision.
- **GATHER INFORMATION** – If there are any potential witnesses, gather their information, such as name, phone number, and any other information that can be useful during the investigation process.
- **DO NOT DELAY MEDICAL TREATMENT** – Have your injuries seen by a medical professional as soon as possible. Do not delay medical treatment; you may have serious injuries that are not immediately or physically apparent.
